COOKIE POLICY

As Funverse Games, INC (hereinafter, “**Company**”, “**We**”, “**Our**” and/or “**Us**”), we use cookies through the use of the hitandboom.com website (the “**Website**”) and the Hit and Boom game (the “**Game**”) (collectively “**Services**”) to the extent permissible under applicable law. The purpose of this Cookie Policy is to inform you about the types and purposes of use of the cookies that are obtained by the users/visitors’ usage of the Services operated by Us.

Please note that this Cookie Policy will be updated and published on our Website from time to time.

What is a Cookie?

Cookies are small text files that mostly consist of letters and numbers, and those Cookies are stored on your computer or mobile device (“**Device**”) when you visit a web site, allowing the device in question to be identified.

By Which Methods Are Cookies Collected and For What Legal Reasons?

In case you visit our Website, in order for you to benefit from our Services, in this regard, your personal data will be processed on the basis of legally exercising the rights through the technically mandatory and permanent cookies and analytical cookies.

What Types of Cookies Are Used?

Our Services use first-party cookies (cookies that are placed by the site you are visiting). Below you can find the different types of cookies we use at our Services. However, we would like to remind you that not all cookies may be used in all jurisdictions or websites:

- o **Necessary / Essential Cookies**

Type: Session Cookies

Administered by: Us

Purpose: These Cookies are essential to provide You with services available through the Website and to enable You to use some of its features. They help to authenticate users and prevent fraudulent use of user accounts. Without

these Cookies, the services that You have asked for cannot be provided, and We only use these Cookies to provide You with those services.

o Cookies Policy / Notice Acceptance Cookies

Type: Persistent Cookies

Administered by: Us

Purpose: These Cookies identify if users have accepted the use of cookies on the Website.

o Functionality Cookies

Type: Persistent Cookies

Administered by: Us

Purpose: These Cookies allow us to remember choices You make when You use the Website, such as remembering your login details or language preference. The purpose of these Cookies is to provide You with a more personal experience and to avoid You having to re-enter your preferences every time You use the Website.

o Tracking and Performance Cookies

Type: Persistent Cookies

Administered by: Us

Purpose: These Cookies are used to track information about traffic to the Website and how users use the Website. The information gathered via these Cookies may directly or indirectly identify you as an individual visitor. This is because the information collected is typically linked to a pseudonymous identifier associated with the device you use to access the Website. We may also use these Cookies to test new pages, features or new functionality of the Website to see how our users react to them.

Which Cookies Are Used for Which Purposes?

Limited to the purposes stated below, we use cookies on our Platforms for various purposes and we process your personal data through these cookies. These purposes are mainly:

-To perform the basic functions necessary for the Platforms to work: For example, the logged-in members do not need to re-enter their password while visiting different pages on the Platforms, ensuring that your active session continues when you switch from one page to another on our site. Disabling these cookies may cause services and features to become unavailable.

-To analyze the Platforms and to increase the performance of the Platforms: For example, integration of different servers on which the Platforms works, determining the number of visitors to the Platforms and adjusting performance accordingly, or making it easier for visitors to find what they are looking for.

To Whom and for What Purposes Can Cookies Be Transferred?

Your personal data processed in the activities that constitute the subject of the Cookie Policy are shared with authorized legal public institutions in judicial processes.

Company matches the information collected online and offline through different methods, or the information collected from you on the Platforms at different times, and uses this information together with the information from other sources such as third parties.

Do We Use Any Cookies from Third Party Companies?

Some cookies, web beacons and other tracking and storage technologies that we use are from third party companies (third party cookies) to provide us with web analytics and intelligence about our sites which may also be used to provide measurement services and target ads.

How Can You Control Cookie Usage?

To use the Platforms, the usage of the cookies is not mandatory; you have the opportunity to customize your preferences regarding cookies by changing the settings of your browser.

If you set your browser to block all cookies, then, you can continue to use the Platforms; however, you may not be able to access the Platforms or may have limited access to all functions of the Platforms and the quality of your user experience may decrease.
